TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this “**Agreement**”) is made on March 31, 2020 (“**Effective Date**”) by Nouryon Chemicals International B.V., Nouryon Chemicals B.V., Nouryon Functional Chemicals LLC and Nouryon Surface Chemistry LLC (each, an “**Assignor**” and collectively, the “**Assignors**”) to Nouryon Chemicals AG (“**Assignee**”). Capitalized terms used but not defined herein shall have the meaning ascribed to such terms in the Purchase Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Nouryon Holding B.V. (“**Seller Parent**”), the indirect parent of the Assignors, is party to that certain Equity and Asset Purchase Agreement, dated as of January 30, 2020 (the “**Purchase Agreement**”), pursuant to which Seller Parent has agreed to cause the Assignors to transfer all of each Assignors’ right, title and interest in, to and under the trademarks and accompanying trademark registrations and applications set forth in Schedule A (the “**Assigned Trademarks**”); and

WHEREAS, the parties are desirous of executing a document suitable for recordation with the United States Patent and Trademark Office, and the equivalent entities or agencies in any applicable foreign countries to the extent applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. ASSIGNMENT.

(a) Assignment. Each Assignor hereby transfers, assigns, and delivers to Assignee, and Assignee hereby acquires from each Assignor, all of such Assignor’s right, title and interest in, to and under (i) the Assigned Trademarks, along with the goodwill inherent in and associated with the Assigned Trademarks, (ii) all registrations and applications for the Assigned Trademarks (including any renewals of such registrations) and (iii) all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns or other legal representatives, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, if any, including, without limitation, all claims for damages by reason of past, present or future infringement, misappropriation, violation or other unauthorized use of the the Assigned Trademarks, with all rights to sue for, enforce, and collect such damages by reason of past, present, or future infringement;

(b) Recordation. This Agreement may be made of record in any government and/or administrative authorities, including in the United States Patent and Trademark Office, as appropriate and desired by Assignee, at the Assignee’s sole cost and expense, and the Assignors authorize and request the relevant authorities to record Assignee as the assignee and owner of the Assigned Trademarks.

(c) Further Assurances. Without prejudice to Section 1(b) above, following the Effective Date, upon the Assignee’s reasonable request, and at the Assignee’s sole cost and

expense, Assignors shall take such reasonable steps and actions, and provide such reasonable cooperation and assistance to the Assignee and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the above Assignment to the Assignee, or any permitted assignees or successors thereto.

2. MISCELLANEOUS.

(a) No Representations. Each of the Parties acknowledge, agree and confirm that, without limiting the representations and warranties expressly provided in the Purchase Agreement, none of the Parties make any representation or warranty whatsoever, express or implied, in this Agreement.

(b) Governing Law; Waiver of Jury Trial. This Agreement, and all issues and questions concerning the construction, validity, interpretation and enforceability of this Agreement and the exhibits and schedules hereto, and all claims and disputes arising hereunder or in connection herewith, whether purporting to sound in contract or tort, or at law or in equity, shall be governed by, and construed in accordance with, the Laws of the State of New York, including its statutes of limitation, without giving effect to any choice of Law or conflict of Law rules or provisions (whether of the State of New York or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of New York. Any dispute directly related to the breach of this Agreement shall be resolved in accordance with Section 11.06 of the Purchase Agreement. EACH PARTY HERETO WAIVES, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY ACTION BASED UPON, ARISING OUT OF OR RELATED TO THIS AGREEMENT, THE PURCHASE AGREEMENT OR THE TRANSACTIONS CONTEMPLATED HEREBY OR THEREBY.

(c) No Third-Party Beneficiaries. Nothing expressed or implied in this Agreement is intended or shall be construed to confer upon or give any Person, other than the Parties hereto, any right or remedies under or by reason of this Agreement, except as contemplated in the Purchase Agreement.

(d) Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

(e) Severability. If any provision of this Agreement is held invalid or unenforceable by any court of competent jurisdiction, the other provisions of this Agreement shall remain in full force and effect. The Parties further agree that if any provision contained herein is, to any extent, held invalid or unenforceable in any respect under the Laws governing this Agreement, they shall take any actions necessary to render the remaining provisions of this Agreement valid and enforceable to the fullest extent permitted by Law and, to the extent necessary, shall amend or otherwise modify this Agreement to replace any provision contained herein that is held invalid or unenforceable with a valid and enforceable provision giving effect to the intent of the Parties.

(f) Entire Agreement. This Agreement (together with the schedules to this

Agreement), the Transaction Documents, the Confidentiality Agreement and the Purchase Agreement constitute the entire agreement between the Parties relating to the transactions contemplated hereby and supersede any other agreements, whether written or oral, that may have been made or entered into by any of the Parties or any of their respective Affiliates or Representatives relating to the transactions contemplated hereby. No representations, warranties, covenants, understandings or agreements, oral or otherwise, relating to the transactions contemplated by the Transactions Documents, exist between the Parties except, in each case, as expressly set forth in the Transaction Documents and the Confidentiality Agreement. Nothing in this Agreement shall alter any liability or obligation of the Parties arising under the Purchase Agreement.

(g) Miscellaneous. Sections 11.02 (Waiver), 11.04 (Assignment), 11.07 (Captions; Counterparts) and 11.10 (Amendments) of the Purchase Agreement shall apply to this Agreement mutatis mutandis.

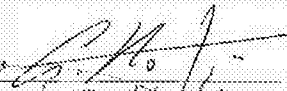
