TRADEMARK ASSIGNMENT

WHEREAS, the Receiver has no independent knowledge regarding the existence of or enforceability of the Marks, has conducted no diligence regarding the Marks, and relying solely upon the representations of Assignee in all matters regarding the Marks, and the Receiver is making no representations or warranties whatsoever;

WHEREAS, the Receiver is also relying solely on the representation of the Assignee that as a matter of trademark law, Assignee can assign the Marks to Assignor;


WHEREAS, Hayward Luxury, Inc., a Delaware corporation, with its principal place of business at 954 Lexington #213, New York, New York (hereinafter, "Assignee"), is desirous of acquiring the Marks and all of Assignor's right, title and interest in the Marks, plus the goodwill of the business in connection with which the Marks are used;

NOW, THEREFORE, effective as of this 10th Day of December, 2020, for good and valuable consideration of an amount separately agreed upon by Assignor and Assignee, the receipt and sufficiency of which consideration is hereby acknowledged, Assignor hereby assigns and transfers unto Assignee, its successors and assigns, (a) all of Assignor's worldwide right, title and interest in and to the Marks, if any, (b) all goodwill of the business associated with and symbolized by the Marks, and thus all goodwill of the ongoing and existing business to which the Marks pertains and with which the Marks are used or are intended to be used, if any, (c) all right, title and interest to sue for, settle, or release any past, present and/or future infringement, dilution or other violation of any right, title or interest in and to the Marks, and to recover, collect or otherwise receive all damages, royalties, profits, interests, revenues, incomes, proceeds, payments, or settlements therefore, and to benefit from all remedies for all claims and demands at law or in equity that Assignor now has or may hereafter acquire on account of any infringement, dilution or other violation of any right, title or interest in and to Marks, if any, (d) all right, title and interest to bring any cancellation, opposition, or other proceeding in the United States Patent and Trademark Office, or before any relevant agency, in connection with or otherwise based upon the Marks, if any, and (e) all right, title and interest to collect and receive any and all income, royalties, proceeds and payments arising by virtue of use of the Marks after the Effective Date hereof, if any. All rights, titles and interests assigned hereunder are to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this Assignment not been made.

This Assignment shall be binding upon and inure to the benefit of Assignor and Assignee and their respective successors and assigns.

The Rhode Island Superior Court shall be the exclusive jurisdiction to decide any dispute arising out of this Trademark Assignment.

Receiver represents that he has the authority to sell property of the Receivership estate.
