TERMINATION AND RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is entered into as of January 19, 2021, by ORIX GROWTH CAPITAL, LLC, a Delaware limited liability company (“Lender”), in favor of SCIENCELOGIC, INC., a Delaware corporation (“Grantor”).

RECITALS

Pursuant to that certain (i) Loan and Security Agreement by and between Lender and Grantor dated as of May 22, 2019 (as the same may be amended, modified or supplemented from time to time, the “Loan Agreement”) and (ii) Intellectual Property Security Agreement by and between Lender and Grantor, dated as of May 22, 2019, recorded with the United States Patent and Trademark Office (“USPTO”) on May 23, 2019, at Reel No. 006652, Frame No. 0844, for the trademarks listed on Schedule B hereto and recorded with the USPTO on May, 23, 2019, at Reel No. 049272, Frame No. 0342, for the patents listed on Schedule C hereto (the “IP Security Agreement”, and together with the Loan Agreement, the “Loan Documents”), Grantor granted and conveyed to Lender a security interest in the entire right, title and interest of Grantor in and to all of Grantor’s right, title and interest in, to and under the Intellectual Property.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender covenants and agrees as follows:

1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or IP Security Agreement, as applicable.
2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:
 - (a) terminates the IP Security Agreement and terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and liens on and security interests in and to the entire right, title, and interest of Grantor in, to and under the Intellectual Property (including without limitation those copyrights, patents, trademarks and mask works listed in Schedules A, B, and C hereto), including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof, granted pursuant to the Loan Documents;
 - (b) re-assigns, grants and re-conveys to Grantor any and all of the right, title, and interest of Grantor that may have been acquired in, to and under any and all of the Intellectual Property; and
 - (c) authorizes the recordation of this Release with the USPTO, at Grantor’s expense.
3. Governing Law. This Release shall be governed by, and construed in accordance with, the internal laws of the State of New York without regard to conflict of law principles.
