RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TRADEMARK RELEASE** is made as of January 15, 2021 (“Effective Date”) executed by ACF FINCO I LP, in its capacity as collateral agent (“Collateral Agent”), in favor of CENTRAL DEFENSE SERVICES, LLC, a Tennessee limited liability company and CHAMPION NATIONAL SECURITY, INC., a Texas corporation (collectively, the “Grantors” and each, a “Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement (the “Trademark Security Agreement”) by the Grantors in favor of the Collateral Agent, dated as of December 14, 2020, each Grantor granted to Collateral Agent a continuing priority security interest in and to all of such Grantor’s right, title and interest in all Trademarks listed on Schedule A attached hereto and all Proceeds (other than Excluded Property) of any and all of the foregoing (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 14, 2020 at Reel 7137, Frame 0278;

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantors as set forth on Schedule A attached hereto (the “Released Trademarks”); and


WHEREAS, any capitalized terms used herein but not otherwise defined shall have the meanings given to them in the Trademark Security Agreement or the Security Agreement (as defined in the Trademark Security Agreement), as applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates, cancels and releases any and all security interests or liens it has against the Trademark Collateral, including, but not limited to, the Released Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, and (A) all reissues, continuations, continuations-in-part, substitutes, extensions or renewals of and improvements on the foregoing and (B) all products and proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future infringement or dilution of any Trademark or any Trademark licensed under any license agreement. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral re-assigns and re-conveys, without recourse or warranty, to the Grantors all of their rights, title and interest in the Released Trademarks.

IN WITNESS WHEREOF, Collateral Agent has caused this Release to be executed by its duly authorized representative as of the Effective Date.


