**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of January 14, 2021 by ORIX Growth Capital, LLC (f/k/a **ORIX Venture Finance LLC** and ORIX Venture Finance, LC) (“**ORIX**”), in favor of **Kaltura, Inc.**, a Delaware corporation (the “**Grantor**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement, dated as of July 6, 2012 (as may be amended, modified, restated, replaced, or supplemented from time to time, the “**Agreement**”), granting to ORIX a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Intellectual Property (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on July 17, 2012 at Reel 4823, Frame 0110.

WHEREAS, Grantor has requested that ORIX hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Intellectual Property as herein provided; and

WHEREAS, Grantor has requested that ORIX provide a document suitable for recording with the USPTO to evidence the release of ORIX’s security interests in and liens on the Intellectual Property as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ORIX hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor’s right, title and interest in, to and under the Intellectual Property, and all goodwill associated therewith, including, without limitation, those trademarks and trademark applications identified in Schedule I hereto and any right, title or interest of ORIX in, to and under such Intellectual Property shall hereby cease and become void; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
