PARTIAL ASSIGNMENT

Now, therefore, for good and valuable consideration, receipt of which is hereby acknowledged, said Jacques Moret, Inc., does hereby assign unto the said Shoptikal LLC, all right, title and interest in and to said trademark ENERGY ZONE, the goodwill therein, Reg. No. 5,499,650, and all other rights acquired from Shoptikal LLC under said Trademark Purchase And Sale Agreement solely as they relate to the goods in Classes 9 and 28.
