**FINAL JUDGMENT**

THIS CAUSE came before the Court on *Plaintiffs' Motion for Final Judgment after Default* (the "Motion"). Having reviewed the Motion, the docket, and the Default entered against Defendant on September 2, 2020, and the Court being otherwise duly advised in the premises, IT IS ORDERED AND ADJUDGED:

1. Plaintiffs' Motion is GRANTED.
2. Final Judgment is hereby entered in favor of each of the Plaintiffs and against Defendant, Red Lambda, Inc. ("Defendant"), which has a principal address of 5507 Title Row Drive, Bradenton, Florida 34210.


