## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of January 22, 2021 (the “Effective Date”), is made by THE BANK OF NEW YORK MELLON, a New York banking corporation, as collateral agent (the “Collateral Agent”) for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of TRANSTAR INDUSTRIES LLC, an Ohio limited liability company (f/k/a Transtar Industries, Inc.) (“Transtar Industries”), TRANSTAR AUTOBODY TECHNOLOGIES LLC, an Ohio limited liability company (f/k/a Transtar Autobody Technologies, Inc.) (“Transtar Autobody”), AXIOM AUTOMOTIVE TECHNOLOGIES LLC, a Delaware limited liability company (f/k/a Axiom Automotive Technologies, Inc.) (“Axiom”), ETX TRANSMISSIONS LLC, a Delaware limited liability company (f/k/a ETX Transmissions, Inc.) (“ETX”), ATCO PRODUCTS LLC, a Delaware limited liability company (f/k/a Atco Products, Inc.) (“ATCO”) and DACCO LLC, an Ohio limited liability company (f/k/a DACCO, Incorporated) (“DACCO”, and, collectively with Transtar Industries, Transtar Autobody, Axiom, ETX and ATCO, the “Grantor”).

WHEREAS, Transtar Holding Company LLC (f/k/a Transtar Holding Company), a Delaware limited liability company (“Borrower”), Speedstar Holding LLC (f/k/a Speedstar Holding Corporation), a Delaware limited liability company (“Holdings”), the other Loan Parties from time to time party thereto, the financial institutions which are now or which hereafter become a party thereto, Silver Point Finance, LLC, a Delaware limited liability company, as L/C Arranger and The Bank of New York Mellon, as Administrative Agent and Collateral Agent entered into that certain Senior Credit Agreement dated April 11, 2017 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, pursuant to that certain Security Agreement, dated as of April 11, 2017, by and among the Collateral Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantor granted to the Collateral Agent, in its capacity as collateral agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, the Grantor and certain other parties thereto executed and delivered an Intellectual Property Security Agreement, dated as of April 11, 2017 (the “IP Security Agreement”), for recording with the United States Patent and Trademark Office (the “USPTO”), the United States Copyright Office and other governmental authorities, as applicable;

WHEREAS, the IP Security Agreement was recorded (i) with the USPTO (a) on June 1, 2018 at Reel/Frame 6340/0295; (b) on May 31, 2018 at Reel/Frame 046276/0710 and (ii) with the United States Copyright Office on May 31, 2018 as Record No. V9959D164; and

WHEREAS, in reliance on the Borrower’s representations and warranties concerning the transactions referenced in that certain Letter regarding Termination of Senior Credit Agreement, dated as of January 22, 2021 (the “Payoff Letter”), delivered by the Borrower to the Collateral Agent, the Collateral Agent has agreed to release all of the Existing Liens (as defined in the Payoff Letter) including, without limitation, the Released IP (as defined below) upon receipt by the Collateral Agent of the Payoff Items (as defined in the Payoff Letter).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the IP Security Agreement, as applicable.

2. Release. The Collateral Agent, without representation, covenant or warranty, express or implied, without recourse to it, and in reliance on the Officer's Certificate without independent investigation, hereby releases its security interests in and to all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature in which the Grantor has granted a security interest to the Collateral Agent, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, the United States Copyright Office or any similar offices in any State of the United States of America or any other country or any political subdivision thereof, and all extensions or renewals thereof, including (i) those listed on Schedule I attached hereto or otherwise included in the Released Assets (ii) all goodwill associated therewith or symbolized thereby and (iii) all other assets, rights and interests that uniquely reflect or embody such goodwill (the "Released IP") arising under the Security Agreement and the IP Security Agreement. If and to the extent that the Collateral Agent has acquired any rights, titles or interests in and to the Released IP under the Security Agreement and the IP Security Agreement, the Collateral Agent, without recourse, representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such rights, titles or interests to the Grantor.

3. Further Assurances. The Collateral Agent agrees, at the sole cost and expense of Grantor, to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments in form and substance reasonably satisfactory to the Collateral Agent), reasonably requested by the Grantor, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.




