## ASSIGNMENT OF TRADE MARKS AND DOMAIN NAMES

This agreement is dated 30-11-2020 2020

### Parties

- (1) **CRYPTOLOGIC OPERATIONS LIMITED** incorporated and registered in Malta with company number 39358 whose registered office is at WH Partners, Level 5, Quantum House, 75 Abate Rigord Street Ta'Xbiex, XBX 1120, Malta (**Assignor**); and
- (2) **DUMARCA GAMING LIMITED** incorporated and registered in Malta with company number 50898 whose registered office is at The Emporium, Level 4, St Louis Street, Msida, MSD 1421, Malta (**Assignee**).

### BACKGROUND

- (A) The Assignor is the registered owner of the Trade Marks and the registrant of the Domain Names (as defined below).
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in this Agreement.
- (C) The Assignor has also agreed to sell and transfer, and the Assignee has agreed to buy, the Domain Names and accordingly the Assignor and the Assignee now wish to enter into this Agreement to formally assign the Domain Name rights to the Assignee.

### Agreed terms

#### 1. Interpretation

The following definitions and rules of interpretation apply in this agreement.

##### 1.1 Definitions:

**Business Day:** a day other than a Saturday, Sunday or public holiday in England when banks in London are open for business.

**Domain Names:** means the domain names as listed in Schedule 2.

**Effective Date:** means 17<sup>th</sup> April 2019

**Trade Marks:** the registered trade marks set out in Schedule 1.

##### 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this agreement.

- 1.3 A **person** includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 The Schedules form part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedules.
- 1.5 References to clauses and Schedules are to the clauses and Schedules of this agreement.
- 1.6 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.7 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.8 This agreement shall be binding on, and inure to the benefit of, the parties to this agreement and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.
- 1.9 A reference to a statute or statutory provision is a reference to it as amended, extended or re-enacted from time to time.
- 1.10 A reference to a statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- 1.11 Any words following the terms **including, include, in particular, for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

## **2. Effective Date**

This agreement is deemed to have taken effect on the Effective Date.

## **3. Assignment**

### **3.1 Trade Marks**

In consideration of the sum of €1.00 (one euro) the receipt of which the Assignor expressly acknowledges, the Assignor hereby assigns to the Assignee absolutely with full title guarantee all its right, title and interest in and to the Trade Marks, including:

- (a) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Trade Marks; and

- (b) all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
- (c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of any of the Trade Marks whether occurring before, on or after the date of this agreement.

### **3.2 Domain Names**

- (a) The Assignor as legal owner agrees to sell and hereby assigns with full title guarantee any and all worldwide rights in the Domain Names to the Assignee with effect from the Effective Date together with all accrued benefits and rights attached thereto.
- (b) The Assignee agrees to buy and accept the registration of and the Assignor agrees to sell and transfer the Domain Names with full title guarantee and free from all encumbrances in accordance with the terms of this Agreement.

## **4. TRANSFER OF THE DOMAIN NAMES**

4.1 Upon execution of this Agreement by both parties:

- (a) the Assignor shall:
  - (i) hold any and all worldwide rights in the Domain Names on trust for the Assignee and shall not by any act or omission permit the Domain Names to be used by or transferred to any third party; and
  - (ii) irrevocably instruct the Assignor's Registrar to transfer the Domain Names to the Assignee and shall procure the formal transfer of the Domain Names to the Assignee by the Assignor's Registrar (who is obliged to provide unconditional written authorisation to the transfer of the Domain Names in accordance with this Agreement to the Assignee and the Assignee's Registrar and obtain and provide to the Assignee any necessary Auth-Info Code).

## **5. Warranties**

The Assignor represents and warrants that:

- (a) it is the sole legal owner of, and owns all the rights and interests in, the Trade Marks; and
- (b) it is properly registered as the applicant or registered proprietor of the Trade Marks listed in 0.

**6. Further assurance**

6.1 At its own expense the Assignor shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement, including registration of the Assignee as applicant for or registered proprietor of the Trade Marks listed in 0.

**7. Entire agreement**

7.1 This agreement constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.

7.2 Each party agrees that it shall have no remedies in respect of any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in this agreement. Each party agrees that it shall have no claim for innocent or negligent misrepresentation or negligent misstatement based on any statement in this agreement.

**8. Variation**

No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

**9. Severance**

9.1 If any provision or part-provision of this agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this agreement.

9.2 If any provision or part-provision of this agreement is invalid, illegal or unenforceable, the parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

**10. Counterparts**

10.1 This agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

10.2 No counterpart shall be effective until each party has executed at least one counterpart.

**11. Third party rights**

This agreement does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this agreement.

**12. Notices**

12.1 Any notice or other communication given to a party under or in connection with this agreement shall be in writing and shall be delivered by hand or by pre-paid first class post or other next working day delivery service at its registered office (if a company) or its principal place of business (in any other case).

12.2 Any notice or communication shall be deemed to have been received:

- (a) if delivered by hand, on signature of a delivery receipt; and
- (b) if sent by next working day delivery service, at 9.00 am on the Business Day after posting or at the time recorded by the delivery service; and

12.3 This clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

**13. Governing law**

This agreement and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of Malta.

**14. Jurisdiction**

Each party irrevocably agrees that the courts of Malta shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with this agreement or its subject matter or formation.
