Pursuant to Section 264(c) of the Delaware General Corporation Law (the “DGCL”) and Section 18-209 of the Delaware Limited Liability Company Act (the “DLLCA”), Wolters Kluwer Health, Inc., a Delaware corporation (the “Corporation”), does hereby certify to the following facts relating to the merger (the “Merger”) of LDI Operations, LLC, a Delaware limited liability company (the “Subsidiary”), with and into the Corporation, with the Corporation remaining as the surviving corporation under the name Wolters Kluwer Health, Inc.:

FIRST: The Corporation is a corporation incorporated pursuant to the DGCL. The Subsidiary is a limited liability company formed pursuant to the DLLCA.

SECOND: An agreement and plan of merger dated as of December 14, 2020 by and between the Corporation and the Subsidiary (the “Agreement of Merger”) has been approved, adopted, certified, executed and acknowledged by the Corporation and the Subsidiary.
