## INTELLECTUAL PROPERTY SECURITY AGREEMENT

INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of December 22, 2020 this “**Agreement**”), between LEGAL SEA FOODS RESTAURANT GROUP INC., a Delaware corporation (the “**Applicable Grantor**”), and delivered to NORTHERN BANK & TRUST COMPANY, in its capacity as collateral agent (in such capacity and together with any successors in such capacity, the “Collateral Agent”) under that certain Security Agreement (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”; capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Security Agreement), dated as of August 9, 2016 made by and among SWRG ACQUISITION CORP., a Delaware corporation (“**SWRG Acq.**”), THE SMITH & WOLLENSKY RESTAURANT GROUP, INC., a Delaware corporation (“**SWRG**”), and STREGA ACQUISITION INC., a Delaware corporation (“**Strega**”) and together with SWRG Acq. and SWRG, collectively, the “**Borrowers**” and each, a “**Borrower**”), and certain affiliates parties thereto, as grantors, pledgors, assignors and debtors (the Borrowers, together with such affiliates, in such capacities and together with any successors in such capacities, the “**Grantors**”, and each, a “**Grantor**”), and the Collateral Agent.

### RECITALS

Pursuant to the terms of the Security Agreement, the Applicable Grantor has granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Applicable Grantor, and has agreed to execute and deliver this Intellectual Property Security Agreement for recording with the United States Patent and Trademark Office and the United States Copyright Office.

NOW, THEREFORE, in consideration of the promises contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. The Applicable Grantor grants and pledges to Collateral Agent for the ratable benefit of the Secured Parties, to secure the payment and performance in full of all of the Secured Obligations, a security interest in and so pledges and assigns to Collateral Agent for the ratable benefit of the Secured Parties the Intellectual Property Collateral, including, without limitation, those copyrights, patents and patent applications and trademarks listed on Exhibits A B and C hereto and including, without limitation, all proceeds thereof (such as, by way of example but not by way of limitation, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations in part thereof).

2. This security interest is granted in conjunction with the security interest granted to Collateral Agent under the Security Agreement. The rights and remedies of Collateral Agent with respect to the security interest granted hereby are in addition to those set forth in the Security Agreement, Loan Agreement and other Loan Documents, and those which are now or hereafter available to Collateral Agent as a matter of law or equity. Each right, power and remedy of Collateral Agent provided for herein or in the Security Agreement, Loan Agreement


or other Loan Documents, or now or hereafter existing at law or in equity, shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Collateral Agent of any one or more of the rights, powers or remedies provided for in this Agreement, the Security Agreement, the Loan Agreement or other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person of any or all other rights, power or remedies. This Agreement shall constitute a Loan Document as defined in the Loan Agreement.

This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or in electronic (i.e., "pdf" or "tif") format shall be effective as delivery of a manually executed counterpart of this Agreement.


