RELEASE OF TRADEMARK SECURITY INTEREST dated as of January 22, 2021 (this "Release"), by JPMORGAN CHASE BANK, N.A., as Administrative Agent. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the U.S. Collateral Agreement, as applicable, referred to below.

Α. 2016 PTSA, August 2016 PTSA, the December 2016 PTSA, the May 2017 PTSA, the July 2017 PTSA, the February 2018 PTSA, the March 2018 PTSA, the September 2018 PTSA, the December 2018 PTSA, the March 2019 PTSA, the June 2019 PTSA, the October 2020 PTSA, and the U.S. Collateral Agreement, the "Security Agreements"), each Security Agreement being among the Company, other Grantors from time to time party thereto and the Administrative Agent.

- B. Pursuant to the Security Agreements, the Grantors granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in, among other things, the trademarks of the Grantors set forth on Schedule I hereto (the "<u>Trademarks</u>").
- C. In connection with the payment and discharge of all Loan Document Obligations of the Borrowers and the other Loan Parties and the termination of all Commitments under the Credit Agreement, the Grantors have informed the Administrative Agent of their desire that the Administrative Agent, on behalf of the Secured Parties, release all right, title and interest granted to it, for the ratable benefit of the Secured Parties, under the Security Agreements in and to the Trademarks.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent herby terminates, releases and discharges any and all security interests it has in the Trademarks and reassigns all right, title and interest it has in the Trademarks, together with the goodwill associated therewith, to the applicable Grantor. The execution and delivery of this Release and the performance of any actions by the Administrative Agent are made without representation or warranty by, or recourse to, the Administrative Agent or any other Secured Party.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
