RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS RELEASE dated as of January 15, 2021 (this “Release”) is made by Madison Capital Funding LLC, acting in its capacity as agent (in such capacity, the “Agent”) under (i) that certain Trademark Security Agreement, dated as of October 22, 2014, by and between Gabriel Performance Products, LLC (“Gabriel”) and Agent (the “2014 Agreement”), (ii) that certain Trademark Security Agreement, dated as of April 5, 2018, by and among Gabriel, Royce International, LLC (“Royce”; Gabriel and Royce, collectively, the “Grantors”), and Agent (the “2018 Agreement”), and (iii) that certain Trademark Security Agreement, dated as of October 30, 2020, by and between Gabriel and Agent (the “2020 Agreement”; and, together with the 2014 Agreement, and the 2018 Agreement, collectively, the “Trademark Security Agreements”).

WHEREAS, pursuant to (i) the 2014 Agreement which was recorded in the records of the United States Patent and Trademark Office on October 27, 2014 at reel 5387, frame 0832, (ii) the 2018 Agreement which was recorded in the records of the United States Patent and Trademark Office on April 10, 2018 at reel 6313, frame 0370 and at reel 6344, frame 0650, and (iii) the 2020 Agreement which was recorded in the records of the United States Patent and Trademark Office on November 8, 2020 at reel 7098, frame 0516, the Grantors granted to the Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantors have requested and Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:


1. Release. The Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate, release and discharge its lien on and security interest in the Trademark Collateral granted pursuant to the Collateral Agreement (as defined in the Trademark Security Agreement) and the Trademark Security Agreement, and (b) discharge and reassign to the Grantors any and all rights, title and interest they have (if any) in the Trademark Collateral (including all associated goodwill).

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America or her delegate to record this Release against the Trademark Collateral. The Agent hereby represents and warrants that it has full authority to execute and deliver this Release.

2. Further Assurances. The Agent agrees to authenticate and deliver to the Grantors, at the expense of the Grantors, such other writings or records and make and do all such other and further acts or things, as the Grantors shall reasonably deem necessary or advisable to effectuate or better evidence the agreements and assignment contained in this Release.
3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
