GRANT OF SECURITY INTEREST  
IN TRADEMARKS

January 19, 2021

WHEREAS, CONANT CAPITAL LLC, a Delaware limited liability company (“Conant Capital”), and SYNERGY MSO, LLC, a Delaware limited liability company (“Synergy MSO” and together with Conant Capital, “Grantors” and each a “Grantor”), are collectively the owners of the trademark applications and registrations listed on Schedule A attached hereto (all such trademarks, registrations and applications, collectively, the “Trademarks”);

WHEREAS, each Grantor has entered into a Security Agreement (as amended, restated, supplemented, or otherwise modified from time to time, together the “Security Agreements”), dated the date hereof, in which Grantors have granted to Salem Investment Partners IV, Limited Partnership, a North Carolina limited partnership with offices at 7900 Triad Center Drive, Suite 333, Greensboro, North Carolina 27409 (“Lender”), a security interest in all of each Grantor’s right, title and interest in general intangibles, including without limitation, the Trademarks and agreed to execute this Grant of Security Interest in Trademarks (this “Grant”).


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Obligations (as defined in the Security Agreements), Grantors do hereby grant to Lender a security interest in all of their right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks. This Grant has been given in conjunction with the security interests granted to Lender under the Security Agreements, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreements, which are incorporated herein by this reference.

The security interest granted to Lender in this instrument shall exist continually until all Obligations (other than contingent obligations for which no claim has been made) have been paid in full. Upon such payment, Lender shall, at Grantors’ request and expense, send such termination statements to Grantors or file them with any applicable filing office.
