## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST TRADEMARKS, dated as of January 20, 2021 (this "Release"), is made by Alter Domus Products Corp., as administrative agent and collateral agent (the "Agent") in favor of California Resources Corporation (the "Grantor").

WHEREAS, pursuant to that certain Credit Agreement, dated October 27, 2020 (the "Credit Agreement") and that certain Second Lien Collateral Agreement, dated as of October 27, 2020 (the "Collateral Agreement"), each in favor of the Agent, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of October 27, 2020, in favor of the Agent, which was recorded in the records of the United States Patent and Trademark Office at Trademark Reel 7088, Frame 0541, on October 27, 2020 (the "Trademark Security Agreement"). Capitalized terms used but not defined herein shall have the meanings attributed to them in the Trademark Security Agreement;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Agent, for the ratable benefit of the Secured Parties, a Lien on and a continuing security interest in all Trademark Collateral; and

WHEREAS, in accordance with the terms set forth in the Credit Agreement and Collateral Agreement, the Agent now desires to release the entirety of its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, including the satisfaction of its obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Collateral Agreement, the receipt of which is hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent, on behalf of itself and the other Secured Parties, hereby terminates, releases and discharges, without recourse to or representation or warranty of any kind by the Agent or such other Secured Parties, its Lien on and a continuing security interest in the Trademark Collateral, including without limitation the marks set forth on Schedule I hereto and all goodwill associated therewith, and discharges, quit claims, and relinquishes unto the Grantor, and reassigns to the Grantor, any and all right, title and interest it has in and to, the Trademark Collateral, including without limitation the marks set forth on Schedule I hereto and all goodwill associated therewith.
2. The Agent hereby authorizes and requests the Commissioner for Trademarks of the United States Patent & Trademark Office to record this Release. The Agent hereby agrees, at the expense of the Grantor, to duly execute, acknowledge, procure and deliver any further documents as may be reasonably necessary to give full effect to this Release.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and interpreted in accordance with, the law of the state of New York.
