

WHEREAS, ASSIGNEE wishes to acquire all of ASSIGNOR'S rights, title, and interest in and to said Service Mark and Common Law Rights, including all the goodwill associated with said Service Mark and Common Law Rights and the right to sue for past infringement of said Service Mark, and said Common Law Rights.

NOW THEREFORE, in consideration of the compensation in an amount agreed to by ASSIGNOR and ASSIGNEE and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns, transfers, and conveys to ASSIGNEE all rights, title, and interest in and to said Service Mark owned by ASSIGNOR, including all of said Common Law Rights and further including all goodwill associated with said Service Mark and Common Law Rights, including the goodwill of the business, which is symbolized by said Service Mark, and additionally including the right to sue and recover for damages, injunctive relief, and all other remedies available for past infringements of said Service Mark. The above WHEREAS clauses are acknowledged and agreed to by the parties and incorporated herein in their entireties of the Assignment for all purposes.


