FORM OF TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "*Assignment*") is effective this 30th day of December, 2020. It is by and between MCMILLAN GROUP INTERNATIONAL, LLC, a limited liability company formed in the State of Arizona ("*Assignor*") and MCMILLAN FIBERGLASS STOCKS, INC., an Arizona corporation ("*Assignee*").

RECITALS

A. Assignor owns all rights, title, and interest in and to the marks, both under common law and the corresponding registrations and applications for registration as set forth in Exhibit 1 (collectively, the "*Marks*") and has certain rights to and valuable goodwill connected with and symbolized by the Marks.

B. Assignee desires to acquire the entire rights, title, and interest in and to the Marks.

AGREEMENT

THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties agree as follows:

1. ASSIGNMENT

1.1 Assignor hereby irrevocably assigns, transfers, and otherwise conveys to Assignee all rights, title, and interest in and to the Marks in the United States and all jurisdictions symbolized by the Marks to the fullest extent that Assignor could have held and enjoyed had this sale, assignment, transfer, and conveyance not been made. This includes, without limitation, all registration rights with respect to the Marks within or outside the United States based in whole or in part upon the Marks, the right to renew any registrations, all rights to prepare derivative marks, any priority right that may arise from the Marks, all goodwill, and all other rights.

1.2 Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and officials in any applicable jurisdictions outside the United States to record the transfer of the registrations and applications for registration set forth in Exhibit 1 to Assignee as assignee of our entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary at any time now or in the future to effect or perfect this assignment or to confirm Assignee's ownership of the Marks.

2. REPRESENTATIONS AND WARRANTIES


2.1 Assignor represents and warrants to Assignee that:
