RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of January 27, 2021 (the "Effective Date") by City National Bank of Florida, as lender (the "Lender"), in favor of Kipu Systems LLC, a Florida limited liability company and its applicable successors and assigns (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement between the Grantor and Lender, dated as of November 30, 2017 (the "Trademark Security Agreement"), the Grantor granted to the Lender to secure the payment of all amounts owing by the Grantor to the Lender under that certain Loan Agreement, dated as of November 30, 2017, between the Grantor and Lender (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement") a security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 5, 2017, at Reel/Frame number 6225/0437, against the Trademarks on Schedule 1 to the Trademark Security Agreement, which is attached as Annex A hereto;

WHEREAS, the Lender now desires to terminate the Trademark Security Agreement, and release its security interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Loan Agreement or the Trademark Security Agreement, as applicable.

2. Release of Security Interest in Trademark Collateral.

The Lender hereby terminates, releases, and discharges its security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral, whether presently existing or hereafter created or acquired, and reassigns to the Grantor any and all right, title, and interest the Lender may have in, to or under the Trademark Collateral, whether presently existing or hereafter created or acquired.

The Lender hereby acknowledges and agrees that the Grantor has completely and timely satisfied its obligations in full, and hereby terminates the Trademark Security Agreement. The Lender hereby confirms the Grantor shall have no further obligations of any kind under the Trademark Security Agreement.

The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America or her or his delegate to record this Release against the Trademark Collateral. The Lender hereby represents and warrants that it has full power and authority to execute and deliver this Release.

3. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
