**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 28, 2021 (the “Effective Date”), is made by Barclays Bank PLC, in its capacity as Agent (the “Agent”), in favor of Precyse Solutions, L.L.C. (predecessor-by-merger to nThrive Solutions, LLC which subsequently merged into nThrive Solutions, Inc.), MedAssets Net Revenue Systems, LLC (n/k/a nThrive Revenue Systems, LLC), Equation Consulting, LLC, Advanced Reimbursement Management, LLC (n/k/a nThrive Reimbursement Management, LLC), HealthCPA, LLC, Optimum Outcomes, Inc. and SSG Sub, LLC (each, a “Grantor” and together, the “Grantors”).

WHEREAS, pursuant to that certain First Lien Guaranty and Security Agreement, dated as of April 20, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Agent, the Grantors and certain other parties thereto, the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral, including the Trademark Collateral;

WHEREAS, pursuant to the Security Agreement, Precyse Solutions, L.L.C. (predecessor-by-merger to nThrive Solutions, LLC which subsequently merged into nThrive Solutions, Inc.) executed and delivered a First Lien Trademark Security Agreement, dated as of April 20, 2016 (the “Precyse Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Precyse Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 21, 2016 at Reel/Frame 5775/0274;

WHEREAS, pursuant to the Security Agreement, MedAssets Net Revenue Systems, LLC (n/k/a nThrive Revenue Systems, LLC) executed and delivered a First Lien Trademark Security Agreement, dated as of April 20, 2016 (the “MedAssets Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the MedAssets Trademark Security Agreement was recorded with the United States Patent and Trademark Office on April 21, 2016 at Reel/Frame 5775/0242;

WHEREAS, pursuant to the Security Agreement, Equation Consulting, LLC executed and delivered a First Lien Trademark Security Agreement, dated as of July 19, 2016 (the “Equation Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Equation Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 19, 2016 at Reel/Frame 5837/0109;

WHEREAS, pursuant to the Security Agreement, Advanced Reimbursement Management, LLC (n/k/a nThrive Reimbursement Management, LLC), HealthCPA, LLC and Optimum Outcomes, Inc. executed and delivered a First Lien Trademark Security Agreement, dated as of March 22, 2017 (the “2017 Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the 2017 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 23, 2017 at Reel/Frame 6017/0413;

WHEREAS, pursuant to the Security Agreement, SSG Sub, LLC executed and delivered a First Lien Trademark Security Agreement, dated as of July 20, 2020 (the “SSG Trademark Security”

Agreement” and together with the Precyse Trademark Security Agreement, MedAssets Trademark Security Agreement, Equation Trademark Security Agreement and 2017 Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the SSG Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 21, 2020 at Reel/Frame 7003/0429;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its Lien on and security interest in and to the Trademark Collateral (as defined under each of the Trademark Security Agreements), including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to any Trademark Collateral under the Security Agreement or Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the applicable Grantor.

3. Termination. The Agent, without representation or warranty of any kind, hereby terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the applicable Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.

6. Counterparts. This Release may be executed in one or more counterparts, all of which, taken together, shall constitute one and the same instrument and may be delivered by facsimile or other means of electronic transmission (including .pdf) and such transmission shall constitute an original for all purposes, and no party seeking to enforce any provision hereof shall be required to produce a manually executed counterpart of this Release. The words “execution,” “signed,” “signature,” “delivery,” and words of like import in or relating to any document to be signed in connection with this Release and the transactions contemplated hereby shall be deemed to include electronic signatures, deliveries or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.


