**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of December 8, 2020, is made by Cortland Capital Market Services LLC, in its capacity as agent (the "Agent"), in favor of Blue Sky Vision, LLC, a Delaware limited liability company (the "Grantor"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of February 18, 2020 (as amended, modified, restated, amended and restated and/or supplemented from time to time, the "Guarantee and Collateral Agreement"), by the Grantor and the other parties party thereto in favor of the Agent, and those certain agreements described on Annex I attached hereto (the "IP Security Agreements" and, collectively with the Guarantee and Collateral Agreement, the "Security Agreements"), the Grantor granted a security interest (the "Security Interest") in certain collateral in favor of the Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Agent now desires to terminate and release the IP Security Agreements and the entirety of its Security Interest in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term "IP Collateral", as used herein, shall mean all of the Grantor's right, title and interest in, to and under the trademarks listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreements, as applicable.
2. Release of Security Interest. The Agent, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of Grantor, and its successors and assigns, its Security Interest in and to the IP Collateral, and the IP Security Agreements and any and all right, title and interest of the Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Agent hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Agent's Security Interest in the IP Collateral.
3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release.
4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
