TRADEMARK ASSIGNMENT AGREEMENT FOR RECORDING

This TRADEMARK ASSIGNMENT AGREEMENT FOR RECORDING ("**Trademark Assignment For Recording**"), effective as of the 29th day of January, 2021, is made by and between **FRIEDMAN AND SOLIMAN ENTERPRISES, LLC ("Seller")**, a Maryland limited liability company, in favor of **CHHJ FRANCHISING LLC ("Buyer")**, a Delaware limited liability company.

WHEREAS, under the terms of an Assignment of Trademark Agreement dated January 29, 2021, Seller has conveyed, transferred, and assigned to Buyer certain intellectual property of Seller, including all rights, title and interest in and to the Assigned Trademarks as defined herein, and has agreed to execute and deliver this Trademark Assignment Agreement For Recording for filing with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions worldwide.

NOW THEREFORE, the Parties, intending to be legally bound, hereby agree as follows:

1. Assignment. In consideration of the mutual promises herein contained, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Seller hereby irrevocably sells, grants, conveys, transfers, and assigns, or confirms as the case may be, to Buyer, its successors and assigns, and Buyer hereby accepts, pursuant to the Assignment of Trademark Agreement dated January 29, 2021, all of Seller's rights, title, and interest in the United States and the world, in and to the trademarks in the Schedule 1 attached hereto and incorporated by this reference herein, together with the goodwill associated therewith and symbolized thereby, and all claims and causes of action with respect to any of the foregoing, including without limitation all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement or other violation, and all other rights, privileges, and protections of any kind whatsoever of Seller accruing under any of the foregoing provided by any applicable law, treaty, or other international convention.

2. Authorization. Seller hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment Agreement For Recording upon request by Buyer.

3. Terms of the Assignment of Trademark Agreement. The parties hereto acknowledge and agree that this Trademark Assignment Agreement For Recording is entered into pursuant to the Assignment of Trademark Agreement dated January 29, 2021, to which reference is made for a further statement of the rights and obligations of Seller and Buyer with respect to the Assigned Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Assignment of Trademark Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Assignment of Trademark Agreement and the terms hereof, the terms of the Assignment of Trademark Agreement shall govern.
