**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of January 29, 2021 by **SILICON VALLEY BANK**, as Administrative Agent (the “*Bank*”), in favor of **PARK PLACE INTERNATIONAL, LLC**, an Ohio limited liability company (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of January 24, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Bank a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on January 24, 2019, at Reel 006535, Frame 0842;

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the certain Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
