## TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** is made between

**(1) Leslie John Emery and Susan Miriam Emery** (both doing business as FAIR SPARES) (the “**Emerys**”);

**(2) The Norvil Motorcycle Co. Limited** (registered number 02497939) whose registered office is at 96-98, The Corner Garage, Cannock Road, Chase Terrace, Burntwood, Staffordshire, WS7 1JP, United Kingdom (“**Norvil Motorcycle**”, and together with the Emerys, the “**Sellers**”, which expression shall, unless it be repugnant to the subject or context thereof be deemed to include their successors and / or permitted assigns );

**AND**

**(3) The Norton Motorcycle Co. Limited (formerly known as ‘Project 303 BIDCO Limited’)** (company number 12545195), whose registered office is at 1 Bartholomew Lane, London, EC2N 2AX, United Kingdom (hereinafter referred to as the “**Buyer**” which expression shall, unless it be repugnant to the subject or context thereof be deemed to, include its successors and / or permitted assigns).

The Sellers and the Buyer are hereinafter individually referred to as such and collectively as the “**Parties**”.

### **WHEREAS :**

A. The Emerys are the owner and proprietor of the trademark ‘NORVIL’ in various countries of the world and by virtue of an Asset Purchase Agreement dated 5 May 2020, the Sellers have assigned the same to the Buyer including the applications filed in USA, more particularly described and listed in the Schedule 1 annexed hereto (hereinafter referred to as the “**said Trademark**”);

- B. The Parties have agreed to execute this Trademark Assignment Agreement in relation to the said Trademark for the proper vesting of the right, title and interest in and to the said Trademark together with the goodwill of the business relating to the goods and services in respect of which it is used or has been used, to and unto the Buyer absolutely.


**NOW THEREFORE**, in consideration of, and subject to, the mutual covenants, agreements, terms and conditions herein contained the mutual benefits to be derived there from and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. With effect from 5 May 2020, the Sellers assign, confirm, transfer, grant, convey and assure absolutely and forever, all its right, title and interest in and to the said Trademark mentioned in the Schedule 1 annexed hereto together with the copyrights and the goodwill and benefit attached to the business concerned and in relation to which the said Trademark is used or has been used, unto and for the exclusive benefits of the Buyer, in perpetuity and throughout the world.
2. The Sellers confirm that, following assignment, said Trademark is the absolute, sole and exclusive property of the Buyer and that the Sellers do not have nor be deemed to have any right, title, claim or interest, benefit or property in or in relation to the said Trademark.
3. The Sellers have not willfully done or omitted to do any act, deed, document, matter or thing as a result of which it was in any manner prevented or precluded from granting, assigning, assuring or transferring unto the Buyer all the right, title, interest, property and benefit in and to the said Trademark to and unto the Buyer as envisaged herein.

4. Recordation and Further Actions: Sellers hereby authorize the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment Agreement upon request by Buyer. Following the date hereof (i.e. 5 May 2020), upon Buyer's reasonable request, Sellers shall take such steps and actions, and provide such cooperation and assistance to Buyer and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence, or perfect the assignment of said Trademark to Buyer, or any assignee or successor thereto.
  
5. Terms of the Asset Purchase Agreement: The Parties hereto acknowledge and agree that this Trademark Assignment Agreement is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Sellers and Buyer with respect to the said Trademark. The representations, warranties, covenants, and agreements contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.
  
6. The Parties waive any objection to, and agree to submit to, the exclusive jurisdiction of the courts of England and Wales.


