RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Release**”) is made as of December 31, 2020, by SILICON VALLEY BANK (the “**Bank**”), in favor of TITLE AGENCY HOLDCO, LLC (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Bank are party to (i) that certain Amended & Restated Loan and Security Agreement dated as of March 11, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Intellectual Property Security Agreement, dated as of March 11, 2019 (the “**Intellectual Property Security Agreement**”);

WHEREAS, pursuant to the Intellectual Property Security Agreement, Grantor granted to the Bank a security interest in all of the Grantor’s right, title and interest in, to and under its intellectual property, including the trademarks set forth on Schedule I hereto (collectively, the “**IP Collateral**”);

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 6588/0921; and

WHEREAS, the Grantor has requested that the Bank execute and deliver this Release to evidence the release of its security interest in the IP Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby irrevocably releases and terminates its security interest in the IP Collateral, and re-assigns and re-conveys to the Grantor any and all right, title or interest the Bank may have in, to or under the IP Collateral.
