## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the “**IP Assignment**”) is made on October 15, 2020 by John K. Lane of Inglewood Associates LLC, the court-appointed receiver of the assets of **American Heritage Billiards, LLC**, an Ohio limited liability company, by power conferred by the Court of Common Pleas, Cuyahoga County, Ohio Case No. CV-20-934277, (the “**Assignor**”) in favor of **Indian Industries, Inc.**, d/b/a Escalade Sports, an Indiana corporation (“**Assignee**”). Capitalized terms used but not otherwise defined herein shall have the meanings set forth in the Asset Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of September 29, 2020 (“**Asset Purchase Agreement**”), by and among the Assignor and the Assignee, the Assignee is purchasing the Game Room Category (as defined in the Asset Purchase Agreement) assets from the Assignor; and

WHEREAS, under the terms of the Asset Purchase Agreement, the Assignor has conveyed, transferred and assigned to Assignee, among other assets, certain intellectual property of Assignor, and has agreed to execute and deliver this IP Assignment, for recording with the United States Patent and Trademark Office, the United States Copyright Office and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor irrevocably conveys, transfers and assigns to Assignee all of Assignor’s rights, title and interests in and to the following (the “**Assigned IP**”): the assets listed on Exhibit A, together with the good will of the business symbolized by the marks and the registrations therefor, and together with all claims, demands, rights, choses in action and rights of recovery for past infringement of the Assigned IP, the same to be held and enjoyed by Assignee, for its own use and benefit, and for that of its successors and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment and transfer not been made.
2. Recordation and Further Actions. Assignor hereby authorize the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office, the Register of Copyrights in the United States Copyright Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Assignee. Following the date hereof, upon Assignee’s reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the assignment of the Assigned IP to Assignee, or any assignee or successor thereto.
3. Terms of the Asset Purchase Agreement. The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Assigned IP. The representations, warranties, covenants, agreements and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein.
4. Successors and Assigns. This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


