SERVICE MARK ASSIGNMENT

This SERVICE MARK ASSIGNMENT (“**Service Mark Assignment**”), dated as of January 31, 2021 is made by Grane Healthcare Company (“**Grane**”), a Pennsylvania corporation, in favor of Grane Hospice Care, Inc. (“**Company**”), a Pennsylvania corporation.

Grane agrees as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grane hereby irrevocably conveys, transfers, and assigns to Company, all of Grane’s right, title, and interest in and to U.S. Service Mark Registration No. 3,745,112 (the “**Assigned Mark**”), together with the goodwill of the business connected with the use thereof; all rights of any kind whatsoever of Grane accruing under the foregoing; any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
2. Recordation and Further Actions. Grane hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Service Mark Assignment upon request by Company. Following the date hereof, upon Company’s reasonable request, Grane shall take such steps and actions, and provide such cooperation and assistance to Company and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned Mark to Company, or any assignee or successor thereto.
3. Successors and Assigns. This Service Mark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
4. Governing Law. This Service Mark Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Service Mark Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
