**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of January 28, 2021 is made by COMVEST CAPITAL IV, L.P., as Agent (the "Agent"), under that certain (i) Notice of Grant of Security Interest in Trademarks, dated as of November 3, 2016 (the "Initial IP SA"), and (ii) Trademark Security Agreement, dated as of June 7, 2018 (the "Subsequent IP SA" and, together with the Initial IP SA, each an "IP SA" and collectively, the "IP SAs"), each entered into by VINTAGE STOCK, INC., a Missouri corporation (the "Grantor") in favor of the Agent (including, with respect to the Initial IP SA, pursuant to an assignment by Wilmington Trust, National Association to Comvest Capital IV, L.P. on June 7, 2018).

WHEREAS, pursuant to the IP SAs and the security agreements related thereto, the Grantor assigned and granted to the Agent a security interest in (i) all of the Grantor's right, title and interest in and to the Trademarks set forth on Schedule A hereto (the "Marks") and all extensions or renewals thereof, (ii) all Proceeds of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date of each IP SA for infringement of any of the Marks or unfair competition regarding the same (collectively, the "IP Collateral");

WHEREAS, an executed copy of the (i) Initial IP SA was recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office (the "USPTO") on November 3, 2016 at Reel 5913, Frame 0888 (and subsequent assignment on June 11, 2018 at Reel 6350, Frame 0876), and (ii) Subsequent IP SA was recorded with the USPTO on June 11, 2018 at Reel 6350 Frame 0886;

WHEREAS, all capitalized terms used but not otherwise defined herein have the meanings given to them in the IP SAs; and

WHEREAS, the Agent has agreed to terminate and release its security interest in all the IP Collateral and to provide this document suitable for recording in the USPTO evidencing and effecting the release, relinquishment and discharge of its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the IP SAs in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge and reassign to the Grantor any and all rights, title and interest it has in and the security interest granted to the Agent in the IP Collateral, including any goodwill of the businesses related thereto. The Agent authorizes and requests that the Commissioner for Trademarks of the USPTO and any other applicable government officer or relevant governmental authority record this Termination and Release of Security Interest in Trademark Rights.


