### TRADEMARK ASSIGNMENT

NOW THEREFORE, for good and valuable consideration paid by Assignee to Assignor, totaling \$160,000. the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, Assignor's entire right, title and interest in and to the Trademark, together with the goodwill of the Trademark, for the United States and for all other countries, territories and regions, including any renewals or extensions thereof that are or may be secured under the laws of the United States or foreign countries now or hereafter in effect and including the subject matter of all claims that may be obtained therefrom for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all income, royalties or payments due or payable as of the effective date of this Assignment or thereafter, including all claims for damages by reason of past, present or future infringement or other unauthorized use, with the right to sue for, and collect the same for its use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal

representatives; and the right to sue for and collect past damages and any other unsatisfied claims regarding any infringement of the Trademark, for its own use and benefit and for the use and benefit of its successors, assigns, or other representatives; and any and all priority rights relating to the Trademark.

The undersigned, its successors, assigns, and legal representatives do hereby agree and covenant without further remuneration to perform the following:

- a) communicate to Assignee or its legal representatives all facts known to the Assignor regarding the Trademark;
- b) testify in any opposition or cancellation proceedings, civil actions, or other legal proceedings in which the Trademark may become involved; and
- c) sign all lawful papers, make all rightful oaths, and do generally everything necessary to aid Assignee, its successors, assigns, and nominees, in maintaining protection on the Trademark in all countries, the expenses incident to said Trademark to be borne by Assignee.

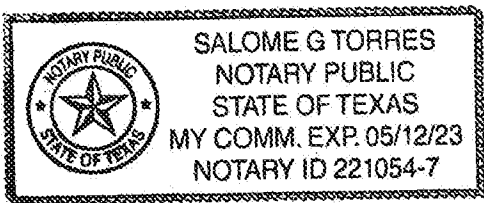
