**INTELLECTUAL PROPERTY RELEASE**

THIS INTELLECTUAL PROPERTY RELEASE (this “Release”) is made as of February 1, 2021, by Maranon Capital, L.P., in its capacity as agent for the Lenders (the “Agent”), in favor of People 2.0 North America LLC, a Florida limited liability company, The Staffing Edge ULC, a British Columbia unlimited liability company, and People 2.0 Global, LLC, a Delaware limited liability company (collectively referred to herein as “Grantor”), pursuant to the Loan Agreement (as defined below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Loan Agreement.

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain Second Lien Term Loan, Guaranty and Security Agreement, dated as of March 6, 2020, by and among Grantor, the other grantors party thereto and Agent (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), Grantor pledged, hypothecated and granted to Agent for its benefit and for the ratable benefit of each Lender and each other Secured Party, a continuing security interest in and to and Lien on all of its Collateral, whether now owned or existing or hereafter created, acquired or arising and wheresoever located;

WHEREAS, Grantor and Agent were parties to that certain Intellectual Property Security Agreement, dated as of March 6, 2020 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “IPSA”), pursuant to which Grantor granted to Agent, for its benefit and the benefit of the Lenders, and reaffirmed its prior grant pursuant to the Loan Agreement of a continuing security interest (the “Security Interest”) in and Lien on all of Grantor’s right, title and interest in, to and under the IP Collateral (as defined below), whether presently existing or hereafter created or acquired, excluding, however, any such property or assets constituting Excluded Property to secure the payment and performance of the Obligations under the Loan Agreement, including the Intellectual Property (as defined below) set forth on Schedule I hereto;

WHEREAS, the IPSA was recorded by the Trademark Division of the United States Patent and Trademark Office on March 6, 2020 at Reel 6884, Frame 0742; and

WHEREAS, Agent now desires to terminate and release the entirety of its Security Interest in the IP Collateral;

NOW THEREFORE, in consideration of the foregoing and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to the terms and conditions of the Loan Agreement, Agent hereby states as follows:

1. Agent hereby terminates the IPSA and terminates, releases, and discharges its Security Interest, and all of its right, title and interest in, to and under the following (collectively the “IP Collateral”) shall hereby cease and become void:

a. all of Grantor’s copyright registrations and copyright applications (collectively, “Copyrights”) and all of the goodwill of the business connected with the use of, and symbolized by, each Copyright, including without limitation those referred to on Schedule I hereto;

b. all of Grantor’s patents and patent applications (collectively, “Patents”), and all of the goodwill of the business connected with the use of, and symbolized by, each Patent, including without limitation those referred to on Schedule I hereto;

c. all of Grantor's trademarks, trademark applications, service marks, trade names, mask works (collectively, "Trademarks"), and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including without limitation those referred to on Schedule I hereto;

d. all reissues, continuations or extensions of the foregoing; and

e. all products and proceeds of the foregoing, including without limitation any claim by such Grantor against third parties for past, present or future infringement or dilution of any Copyright, any Patent, or any Trademark.


2. Agent hereby agrees, at Grantor's expense, to execute and deliver to Grantor such documents, instruments, notices and releases as Grantor shall reasonably request to evidence the release of the Security Interest contemplated hereby.

3. This Release and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release or the facts or circumstances leading to its execution, whether in contract, tort or otherwise shall, in accordance with Section 5-1401 of the General Obligations Law of the State of New York, be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
