**ASSIGNMENT OF GRANT OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This ASSIGNMENT OF GRANT OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Assignment"), dated as January 5, 2021, is entered into by and between CITICORP NORTH AMERICA, INC., ("Assignor") and WILMINGTON SAVINGS FUND SOCIETY, FSB ("Assignee"). All capitalized terms used herein and not otherwise defined shall have the respective meanings given to such terms, directly or by reference, in the Trademark Security Agreement referred to below.

WHEREAS, pursuant to that certain Credit Agreement dated as of April 30, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), American Multi-Cinema, Inc., a Missouri corporation (the "Grantor") and the other grantors party thereto entered into a Pledge and Security Agreement with the Assignor, dated as of April 30, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, Grantor executed and delivered that certain Notice of Grant of Security Interest in Trademark, dated as of April 30, 2013 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement and the Trademark Security Agreement, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of Grantor, Grantor mortgaged, pledged, hypothecated and granted to Assignor for the benefit of the Secured Parties, a lien on and security interest in (the "Security Interest") all of the Grantor's right, title and interest in, to and under the following Collateral of Grantor: (a) all Trademarks of the United States of America owned by Grantor, in each case, then existing or thereafter acquired, including, without limitation, those referred to on Schedule I hereto and excluding any intent-to-use United States trademark applications for which an amendment to alleged use or statement of use has not been filed under 15 U.S.C. §1051(c) or 15 U.S.C. §1051(d), respectively, or, if filed, has not been deemed in conformance with 15 U.S.C. §1051(a) or examined and accepted by the United States Patent and Trademark Office; (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark described in clause (a) above; and (c) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any such Trademark or (ii) injury to the goodwill associated with any such Trademark (the "Trademark Collateral");

WHEREAS, Assignor recorded the Trademark Security Agreement with the United States Patent and Trademark Office on April 30, 2013, at Reel 5017, Frame 0209;


WHEREAS, pursuant to a Successor Agent Appointment and Agency Transfer Agreement, dated as of January 5, 2021, Assignor resigned as Administrative Agent and Collateral Agent under the Credit Agreement, the Pledge and Security Agreement and the Trademark Security Agreement, and Assignee assumed such role, and Assignor agreed to execute and deliver such documentation as may reasonably be necessary to evidence the resignation and appointments described therein, and to assign the Trademark Security Agreement; and

WHEREAS, Assignee has requested Assignor to execute and deliver this Assignment to effectuate and confirm the assignment of the Security Interest in the Trademark Collateral, and for purposes of recordation in the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in, to and under, the Trademark Collateral and the Trademark Security Agreement, including, without limitation, its Security Interest in the Trademark Collateral. The foregoing assignment is made as-is, where is and without representation or warranty of any kind, whether express or implied, and without recourse to Assignor.
