TRADE MARK ASSIGNMENT

This Deed of assignment ("Assignment") is dated 27th January 2021.

BETWEEN

Nomad Barber Grooming Limited incorporated and registered in England and Wales with company number 10329266 whose registered office is at Unit 6 Heritage Business Centre, Derby Road, Belper, England, DE56 1SW ("Assignor")

AND

Nomad Barber UK Limited incorporated and registered in England and Wales with company number 09197513 whose registered office is at 8 Heneage Street, London, England, E1 5LJ ("Assignee")

BACKGROUND

- (A) The Assignor is the proprietor of the Trade Marks (as defined below).
- (B) The Assignor has agreed to assign the Trade Marks to the Assignee on the terms set out in this Assignment.

ASSIGNMENT

1. In this Assignment "Trade Marks" means the registered trade marks and the unregistered trade marks short particulars of which are set out in Schedule 1 attached.
2. In consideration of the sum of £1.00 the receipt and sufficiency of which is hereby acknowledged, the Assignor assigns to the Assignee absolutely, with full title guarantee and free from encumbrances all its right, title and interest in and to the Trade Marks, including:
 - a) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the Trade Marks;
 - b) all statutory and common law rights attaching to the Trade Marks, together with the goodwill of the business relating to the goods or services in respect of which the Trade Marks are registered or used; and
 - c) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement of any of the registered Trade Marks whether occurring before, on or after the date of this agreement, excluding and reserving to the Assignor all goodwill of the business of the Assignor relating to the goods and services in respect of which the Trade Marks are registered.

GENERAL

3. This Assignment shall be binding upon and shall inure to the benefit of the parties, their respective successors and permitted assignees as well as any subsidiary companies of the parties.

4. This Assignment constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral relating to its subject matter.
5. This Assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.
6. If any provision or part-provision of this Assignment is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this Assignment.
7. This Assignment and any dispute or claim (including non contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the laws of England and Wales.
8. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non contractual disputes or claims) arising out of or in connection with this Assignment or its subject matter or its formation.






