WHEREAS, Assignee is a wholly owned subsidiary of Assignor, under common control and/or ownership.


WHEREAS, pursuant to a separate transaction agreement between Assignor and Assignee, the present assignment is desired.

This assignment is effective as of December 23<sup>rd</sup>, 2020.




