## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “Release”) dated as of January 29, 2021, is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent for the lenders party to the Credit Agreement (“Agent”).

### RECITALS:

Slomin’s, Inc., a New York corporation (“Company”) and Agent entered into that certain Amended and Restated Pledge and Security Agreement (“Agreement”), dated as of April 29, 2016, and recorded as to Trademarks with the Trademark Division of the United States Patent & Trademark Office on May 5, 2016, at Reel 005786, Frame 0757 pursuant to which the Company granted to Agent a lien on and security interest in, among other things, certain Trademarks owned by the Company. Capitalized terms used herein and not defined shall have the same meanings for such terms set forth in the Agreement.

The Company has requested Agent to release, and Agent has agreed to release, its lien on all Trademarks pledged pursuant to the Agreement.

### AGREEMENT:

Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Company pursuant to the Agreement in all Trademarks, including, without limitation, the Trademarks identified on Schedule A annexed hereto (collectively, the “Released Collateral”), and all liens, security interests, charges or other encumbrances in favor of Agent in the Released Collateral shall hereby terminate and revert to the Company and all right, title and interest of Agent in the Released Collateral will hereby cease, terminate and become void.
