TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (“Release”) is made as of February 4, 2021, by GOLUB CAPITAL MARKETS LLC, as collateral agent (in such capacity, “Grantee”), in favor of AVERETEK LLC, a Washington limited liability company (“Averetek”) and AMBER ROAD, INC., a Delaware corporation (together with Averetek, “Grantors”, and each a “Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Grantors and Grantee are parties to that certain Trademark Security Agreement dated as of July 2, 2019 (the “Security Agreement”) pursuant to which Grantors granted a continuing security interest to Grantee in certain Trademark Collateral (as defined therein) as security for certain obligations owing by Grantors to Grantee, including the Trademark Collateral set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 15, 2019, at Reel 6694, Frame 0091;

WHEREAS, Grantors have requested that Grantee release its security interest in the Trademark Collateral and reassign any and all rights in the same to the applicable Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases, relinquishes, terminates in its entirety and discharges fully its security interest in all of such Grantor’s right, title and interest in, to and under the following:

(i) each Trademark registration and Trademark application owned by such Grantor, including, without limitation, the Trademark registrations and Trademark applications referred to in Schedule 1 annexed hereto;

(ii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(iii) all products and proceeds of the foregoing, including, without limitation, any claim by Grantors against third parties for past, present or future infringement, misappropriation, dilution, violation or impairment of any Trademark registration owned by such Grantor including, without limitation, the Trademark registrations referred to in Schedule 1 annexed hereto and the Trademark registrations issued with respect to the Trademark applications referred to in Schedule 1 annexed hereto.

2. Grantee hereby releases its security interest in the Trademark Collateral and reassigns, grants and conveys to the applicable Grantor, without any representation, recourse or undertaking by Grantee, any and all of Grantee’s right, title and interest in and to the Trademarks and the Trademark Collateral.


