("TISI"), together with all amendments and restatements (the "Credit Agreement"), does hereby terminate and release its interest in and to that specific Trademark Collateral shown on Exhibit "A" attached hereto (the "Released Trademark"), arising from that certain Trademark Security Agreement dated as of August 30, 2019, between Agent, Borrower, TISI, Furmanite Worldwide, LLC, a Delaware corporation, and Rocket Acquisition, LLC, a Delaware corporation, which was recorded in the United States Patent and Trademark Office on December 18, 2019, at Reel/Frame 6816/0697, and re-recorded on January 22, 2020, at Reel/Frame 6837/0410 ("Trademark Security Agreement").

This Partial Release is intended to release and discharge only the lien on and security interest in the Released Trademark and does not release or discharge Agent's lien on and security interest in any other properties that are subject to the Trademark Security Agreement.
