## Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks (the "Release") is made as of February 4, 2021, by ROYAL BANK OF CANADA, in its capacity as collateral agent (the "Collateral Agent") pursuant to the Second Lien Security Agreement, dated as of May 1, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Second Lien Security Agreement") in favor of GUIDEHOUSE INC. (f/k/a NAVIGANT CONSULTING, INC.), a Delaware corporation, GUIDEHOUSE MANAGED SERVICES LLC (f/k/a NAVIGANT CYMETRIX CORPORATION; a surviving entity to CARECLARITY, INC.), a Delaware corporation (individually, a "Pledgor", and, collectively, the "Pledgors").

### W I T N E S S E T H:

WHEREAS, pursuant to the terms and conditions of the Second Lien Security Agreement in favor of the Collateral Agent, the Pledgors entered into that certain Second Lien Trademark Security Agreement dated as of October 11, 2019 (the "Second Lien Trademark Security Agreement");

WHEREAS, pursuant to the terms and conditions of the Second Lien Trademark Security Agreement and the Second Lien Security Agreement, each Pledgor pledged and granted to the Collateral Agent for the benefit of the secured parties a lien on and security interest in all of the right, title and interest of such Pledgor in, to and under the Trademark Collateral (as defined in the Second Lien Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule I attached hereto (the "Trademarks");

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 11, 2019 at Reel/Frame 006769/0658; and

WHEREAS, the Collateral Agent desires to release, terminate, discharge and relinquish the security interest and lien in the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent on behalf of itself and the secured parties, hereby terminates and cancels the Second Lien Trademark Security Agreement and releases, terminates, discharges and relinquishes unto each applicable Pledgor the continuing security interest in, and lien on, the Trademark Collateral and otherwise assigns, grants and conveys to each applicable Pledgor, without recourse, any and all right, title and interest the Collateral Agent or the secured parties may have in, to or under to the Trademark Collateral in order to revest in each applicable Pledgor full and unencumbered title to said Trademark Collateral.

Each Pledgor, or any successor to each Pledgor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral), is hereby authorized to record this Release in the United States Patent and Trademark Office.
