GRANT OF SECURITY INTEREST
IN TRADEMARKS

January 22, 2021

WHEREAS, US TARP, INC., a Michigan corporation ("Grantor"), is the owner of the trademark applications and registrations listed on Schedule A attached hereto, which Schedule contains a true, correct and complete list of trademark registrations by Grantor (all such trademarks, registrations and applications, collectively, the "Trademarks");

WHEREAS, Grantor has entered into a Security Agreement (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), dated on or about May 9, 2018, in which Grantor has granted to Salem Investment Partners IV, Limited Partnership, a North Carolina limited partnership with offices at 7900 Triad Center Drive, Suite 333, Greensboro, North Carolina 27409 ("Salem"), and Badger Capital III, L.L.C., a North Carolina limited liability company with offices at 802 Northern Shores Lane, Greensboro, North Carolina 27455 ("Badger" and together with Salem, "Lenders"), a security interest in all general intangibles, including without limitation, the Trademarks and agreed to execute grants such as this from time to time to update Lenders on the status of Grantor's trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Obligations (as defined in the Loan and Purchase Agreement dated on or about May 9, 2018 among Grantor, certain affiliates and Lenders), Grantor does hereby grant to Lenders a security interest in all of its right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks. This Grant has been given in conjunction with the security interest granted to Lenders under the Security Agreement, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.


