TRADEMARK ASSIGNMENT

This trademark assignment ("Assignment"), dated April 13, 2018, is by and between TW Holdings, Inc. RECITALS

WHEREAS, Assignor is the current registrant of the following U.S. Trademark Registrations: (i) 2,519,313; (ii) 4,660,480; (iii) 4,656,975; and (iv) 4,660,479 (collectively, the "Registrations");

WHEREAS, pursuant to a certain Asset Purchase Agreement, Assignor conveyed to Assignee all of Assignor's right, title, and interest in and to the Registrations (including, without limitation the goodwill of the business appurtenant to and symbolized by each mark listed in each Registration); and

WHEREAS, Assignee is desirous of reflecting this change in ownership of the Registrations with the United States Patent and Trademark Office (the "PTO").

NOW, THEREFORE, in consideration of the premises above, and other good and valuable consideration (the receipt and sufficiency of which each Party expressly acknowledges), the Parties agree as follows:

AGREEMENT

1. Assignee may record this Assignment with the PTO.
2. Assignor agrees to execute any additional documents, and take any further actions, necessary or reasonably requested by Assignee, to effect, perfect, or evidence this Assignment, at no further cost to Assignor.
3. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which taken together shall constitute one and the same instrument. Photographic, fax, and/or scanned copies of such signed counterparts may be used in lieu of the originals of this Assignment for any purpose, and shall be deemed as effective as an original signature.
