**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of January 29, 2021, by and from People's United Bank, a national banking association with an office at 850 Main Street, Bridgeport, Connecticut 06604 ("Bank"). 

1. Release of Security Interest. Bank hereby confirms the irrevocable termination, release, and discharge of the security interest in and to the Grantor's Trademarks, including the Scheduled Trademarks, arising under the Trademark Security Agreement.
2. Authorization to Record. Bank authorizes and requests the Commissioner for Trademarks and any other government officials to record and register this Release.
