**NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST  
(INTELLECTUAL PROPERTY)**

This NOTICE OF SUCCESSOR AGENT AND ASSIGNMENT OF SECURITY INTEREST (INTELLECTUAL PROPERTY) (this “Notice”), is made and entered into as of February 8, 2021 by and among Bank of America, N.A. (“Bank of America”), as Administrative Agent, Swingline Lender and L/C Issuer under the Security Agreement (as defined below) (in such capacity, the “Resigning Agent” pursuant to the Loan Sale and Assignment Agreement (defined below)), and Fortress Credit Corp., a Delaware corporation (“Fortress”), as the successor to Bank of America (in such capacity, the “Successor Agent” pursuant to the Loan Sale and Assignment Agreement (defined below)).

WHEREAS, the Loan Parties, the Lenders, and Bank of America, are party to that certain Security Agreement, dated as of June 13, 2018 (as amended, restated, extended, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Loan Sale and Assignment Agreement, dated as of the same date hereof (“Assignment Agreement”) the parties to the Security Agreement desire to appoint Fortress as Administrative Agent under the Security Agreement, and Bank of America has agreed to resign as Administrative Agent under the Security Agreement (the “Agent Transition”);

WHEREAS, pursuant to the Loan Documents, the Borrowers granted to Bank of America a security interest in certain collateral;

WHEREAS, Bank of America and the Loan Parties entered into the Notices of Grant of Security Interest as identified on Schedule A attached hereto (the “IP Notices”).

WHEREAS, the IP Notices were recorded with the United States Patent and Trademark Office and United States Copyright Office as identified on Schedule A attached hereto; and

WHEREAS, pursuant to the Assignment Agreement and Agent Transition, the Resigning Agent resigned as, and Successor Agent was appointed and accepted appointment as Administrative Agent under the Loan Documents, with all of rights, powers and duties of the Administrative Agent under the Loan Documents, including in and to the IP Notices.

NOW, THEREFORE, in consideration of the mutual agreements, provisions and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Security Agreement, Assignment Agreement, or other Loan Documents, as applicable.


2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Assignment Agreement, the Resigning Agent has ceased to be the Administrative Agent under the Loan Documents and is succeeded to and replaced by the Successor Agent as Administrative Agent under the Loan Documents, including with respect to all right, title and interest in and to the IP Notices with all attendant liens, rights, title, assignments and interests (including security interests) pertaining to or arising from the Collateral set forth in the IP Notices. Nothing herein shall be deemed to terminate, interrupt, or impair the continuity of the security interest in and to the Collateral granted to the Resigning Agent, including the IP Notices and the Collateral identified on Schedule A attached hereto, which security interest is now succeeded by and transferred to the Successor Agent.

3. Incorporation. All terms set forth in the Assignment Agreement are hereby incorporated herein by reference with the same force and effect as though fully set forth herein. To the extent that the terms set forth herein are inconsistent with the terms of the Assignment Agreement, the terms set forth in Assignment Agreement shall control.


