THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of the date of last signature below (the "Effective Date") by and between Park Hotels & Resorts Inc., with an address at 1775 Tysons Boulevard, 7th Floor, Tysons, Virginia 22102 ("Park"), and Hilton International Holding LLC, with an address at 7930 Jones Branch Drive, McLean, Virginia 22102 ("Hilton") (each a "Party," and collectively, the "Parties").

WHEREAS, Hilton assigned several trademarks and their corresponding registrations to Park in a Trademark Assignment dated September 15, 2016 ("Trademark Agreement").

WHEREAS, the Trademark Agreement inadvertently assigned Reg. No. 2,446,357 for the mark SPENCER'S, together with the goodwill of the business associated with the mark, to Park (the "Mark").

WHEREAS, the Parties wish to correct the error through this assignment of the Mark back to Hilton.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby agree as follows;

1. Park hereby assigns, transfers and conveys to Hilton all right, title and interest in and to the Mark, and all registrations therefor and common law rights therein, together with the goodwill of the business symbolized by the Mark, and all rights of action accrued and to accrue under and by virtue hereof, including the right to sue and recover for past and future infringement of the Mark.

2. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


