RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (“**Release**”), effective as of February 8, 2021, given by Credit Suisse AG (as successor to Credit Suisse First Boston), with an address at Eleven Madison Avenue, New York, NY 10010, as Collateral Agent for the Secured Parties (“**Agent**”) to Oil States Industries, Inc., a Delaware corporation, with an address at 7701 South Cooper Street, Arlington, TX 76001 (“**Grantor**”), as follows:

WITNESSETH

WHEREAS, the Grantor executed that certain U.S. Security Agreement, dated as of February 14, 2001 (as amended, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and granted to the Agent a security interest in the United States trademark registrations and applications set forth on Schedule A attached hereto (the “**Trademarks**”);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed an Assignment of Security Interests in Trademarks, dated December 2, 2002 (the “**Trademark Security Agreement**”), which was recorded by the U.S. Patent and Trademark Office on December 3, 2002, at Reel / Frame no. 2631/0151;

WHEREAS, pursuant to the U.S. Payoff Letter dated October 30, 2003, the Agent, among other things, released and discharged any and all security interests, liens, mortgages, pledges, encumbrances and assignments in any of the property of Grantor under the Security Agreement;


WHEREAS, the Grantor has requested that the Agent release of record the Agent’s security interest in the Trademarks, and terminate of record the encumbrance created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Security Agreement and reassigns, in each case without recourse to or warranty by the Agent, all right, title and interest it has in the Trademarks to the Grantor.




