ARTICLES OF MERGER  
OF  
D:FLOURED, LLC,  
A WASHINGTON LIMITED LIABILITY COMPANY  
WITH AND INTO  
NUFLOURS, INC., A WASHINGTON CORPORATION

In accordance with RCW 23B.11.090, Phebe Rossi being the President of NufLOURS, Inc., and in accordance with RCW 25.15.421, Phebe Rossi being the sole member of D:Floured, LLC, do hereby certify as follows:

1. Constituent Entities.

1.1 D:Floured, LLC, a Washington limited liability company (UBI# 603 086 748) (the "Disappearing Company").

1.2 NufLOURS, Inc., a Washington corporation (UBI# 604 597 346) (the "Surviving Corporation").

2. Surviving Entity. NufLOURS, Inc., a Washington corporation, shall be the surviving corporation.

3. Plan of Merger.

3.1 The effective date of merger shall be August 1, 2020.

3.2 As of the effective date of the merger, the Surviving Corporation shall authorize and issue shares of its common stock to the member of the Disappearing Company, on a one for one basis, in exchange for all issued and outstanding membership units of the Disappearing Company.

3.3 Upon the effective date of the merger: (i) the separate corporate existence of the Disappearing Company shall cease; (ii) title to all assets owned by the Disappearing Company shall be vested in the Surviving Corporation, without reversion or impairment; and (iii) the Surviving Corporation shall assume all liabilities of the Disappearing Company.

3.4 Any proceeding pending by or against the Disappearing Company or the Surviving Corporation may be continued as if such merger did not occur, or the Surviving Corporation may be substituted in the proceeding for the Disappearing Company.

4. Approval of Merger. The Agreement and Plan of Merger dated as of August 1, 2020, (the "Plan of Merger"), was duly approved, adopted, and executed by the sole member of the disappearing constituent limited liability company in accordance with RCW 25.15.421, and was duly approved, adopted, and executed by the Board of Directors of the Surviving Corporation by an affirmative consent of the Board of Directors and a vote of the shareholder of the

Surviving Corporation was not required pursuant to RCW 23B.11.030(7)(a). Pursuant to the Plan of Merger, the Disappearing Company will merge with and into the Surviving Corporation (the "Merger").

5. **Date of Merger.** The merger shall be effective August 1, 2020.
