TRADEMARK ASSIGNMENT AGREEMENT

2. The Assignor warrants that there are no other assignments of rights related to the Marks or the Applications.

3. The Assignor assigns its entire interest, the good will and all other rights in and to the Marks and under the Applications to the Assignee.

4. This Agreement shall be binding upon and inure to the benefit of the parties, their successors and assigns.
