THIRD: The name of the entity surviving the Merger is "Great Lakes Dredge & Dock Company, LLC".

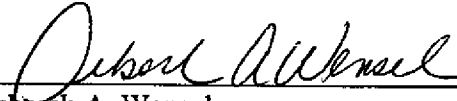
FOURTH: The Merger Agreement is on file at the principal place of business of the Surviving Entity, located at 2122 York Road, Oak Brook, Illinois 60523.
