**EXCLUSIVE INTELLECTUAL PROPERTY LICENSE (SHORT FORM)  
(PATENT, TRADEMARK, COPYRIGHT)**

This Exclusive Intellectual Property License Agreement (the “**License**”) is entered into as of June 2, 2010 (“**Effective Date**”) by and between Trade Box, LLC, a California limited liability company with a place of business at 5826 Uplander Way, Culver City, California 90230 (the “**Licensor**”), and Tre Milano, LLC, a California limited liability company with a place of business at 5826 Uplander Way, Culver City, California 90230 (the “**Licensee**”). Licensor and Licensee shall be referred to herein individually as a “**Party**” and collectively as the “**Parties**”.

**RECITALS**

WHEREAS, Licensor is the owner of all right, title and interest in and to the trademarks identified and listed in Exhibit A attached hereto and incorporated herein (hereinafter collectively the “**Marks**”); and,

WHEREAS, Licensor is the owner of all right, title and interest in and to the copyrights identified and listed in Exhibit B attached hereto and incorporated herein (hereinafter collectively the “**Copyrights**”); and,

WHEREAS, Licensor is the owner of all right, title and interest in and to the patents identified and listed in Exhibit C attached hereto and incorporated herein (hereinafter collectively the “**Patents**”); and,

WHEREAS, Licensor owns or has the right to use, and to the extent legally required, to authorize the use by Licensee of, each of the domain names listed in Exhibit D attached hereto and incorporated herein (hereinafter collectively the “**Domain Names**”). The Marks, the Copyrights, the Patents and the Domain Names shall be referred to herein collectively as the “**IP**”; and,

WHEREAS, Licensee wishes to and has been using the IP since the Effective Date, throughout the world, in connection with the Licensed Products (as defined below) and Licensor is willing to grant to Licensee, as of the Effective Date and continuing during the Term of this License (as defined below) an exclusive license to use the IP for such purposes;

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

**LICENSE**

1. **RECITALS.** The foregoing Recitals are deemed incorporated herein by reference.
2. **GRANT.** For the duration of the Term (as defined below), throughout the world, and subject to the terms and conditions hereof, and of the Long Form License (as defined below), Licensor hereby grants to Licensee an exclusive license, with the right to sublicense, to use the IP on or in connection with the development, manufacture, marketing, promotion,

advertising, distribution, sale and other exploitation of all goods and services associated or identified with or by the IP (the “**Licensed Products**”).

- 3. **TERM.** This License shall be effective as of the Effective Date and shall remain in force so long as any of the IP continues to be in use by Licensee, and may only be terminated in the event of uncured default, by the Licensee, of the royalty payment obligation set forth in the Long-Form License.
- 4. **CONTROLLING DOCUMENT.** This Agreement is subject to all of the terms and conditions set forth in that certain Intellectual Property License Agreement executed by the Parties as of June 2, 2010 (the “**Long Form License**”). In the event of any conflict between this License and the Long Form License, including with respect to any definitions, then the Long Form License shall control.

IN WITNESS WHEREOF, each Party has executed this Agreement as of the date affixed with its signature.
