ASSIGNMENT

AND WHEREAS, **COVIS PHARMA GmbH**, a limited liability company (Gesellschaft mit beschränkter Haftung) duly organized under and pursuant to the laws of **SWITZERLAND** and having a principal place of business at **GRAUFENAUWEG 12, 6300 ZUG, SWITZERLAND**, registered with the commercial register of the Canton of Zug under number CHE 403-495-189 (hereinafter referred to as "the Assignee"), is desirous of acquiring, and did acquire, any and all rights that Assignor had in and to the Trademarks and the registrations and applications therefor, together with the goodwill of the business symbolized by the Trademarks, along with the right to recover for damages and profits for past infringements thereof;




