**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (“Release”) is executed as of February 3, 2021, by FIRSTBANK (as successor by merger to Franklin Synergy Bank) (“Secured Party”), in favor of CLINICANYWHERE, LLC, a Delaware limited liability company (the “Released Party”).

WHEREAS, pursuant to the terms of that certain Supplemental Grant of Security Interests in United States Trademarks, dated July 20, 2020, executed by the Released Party in favor of the Secured Party (the “Security Agreement”), as recorded with the United States Patent and Trademark Office (“USPTO”) on July 22, 2020, at Reel 007005, Frame 0034, the Released Party granted to the Secured Party, among other collateral as set forth therein, a security interest in and lien on the trademarks and trademark applications identified on Schedule A attached hereto (collectively the “Trademark Collateral”); and

WHEREAS, the Secured Party wishes to release the security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party states as follows:

The Secured Party hereby terminates, releases, and discharges its security interest in and lien on the Trademark Collateral, and the Secured Party hereby assigns and transfers to the Released Party without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Trademark Collateral together with the goodwill of the business symbolized thereby, including, without limitation, each of the applications, publications or grants identified on Schedule A attached hereto, effective as of the date set forth above.

The Secured Party understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
