ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS dated as of February 11, 2021 (this "Assignment"), by and among CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as successor Administrative Agent and successor Collateral Agent (in such capacity, the "Successor Agent"), GOLDMAN SACHS BANK USA, as existing Administrative Agent and existing Collateral Agent (in such capacity, the "Existing Agent"), UNITED NATURAL FOODS, INC., a Delaware corporation (the "Lead Borrower"), SUPERVALU INC., a Delaware corporation (the "Co-Borrower" and, together with the Lead Borrower, collectively, the "Borrowers" and each, a "Borrower"), and the other Grantors (as defined below) party hereto (together with the Borrowers, the "Loan Parties"). Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Credit Agreement and Successor Agent Agreement (each defined below), as applicable.

WHEREAS, the Borrowers, the banks, financial institutions and other Persons from time to time parties thereto, and Existing Agent entered into that certain Term Loan Agreement, dated as of October 22, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, the parties are entering into that certain Successor Agency Agreement, dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Successor Agent Agreement"), pursuant to which the Existing Agent is resigning as the Administrative Agent and Collateral Agent and the Successor Agent is being appointed to act as the successor Administrative Agent and successor Collateral Agent under the Loan Documents;

WHEREAS, in connection with the Successor Agent Agreement, the Existing Agent is assigning to the Successor Agent each of the Liens and security interests granted to the Existing Agent in its capacity as the Collateral Agent under the Collateral Documents, including that certain (i) Trademark Security Agreement, dated as of October 22, 2018, made by United Natural Foods, Inc., Blue Marble Brands, LLC, Natural Retail Group, Inc., Tony's Fine Foods, UNFI Canada, Inc., SUPERVALU INC., Associated Grocers of Florida, Inc., Hornbacher's, Inc., Shoppers Food Warehouse Corp., SUPERVALU Holdings, Inc., SUPERVALU Licensing, LLC, SUPERVALU Pharmacies, Inc., Unified Grocers, Inc., and W. Newell & Co., LLC. in favor of Goldman Sachs Bank USA (recorded with the United States Patent and Trademark Office at Reel/Frame 6465/0883), (ii) Copyright Security Agreement, dated as of October 22, 2018, made by United Natural Foods, Inc., SUPERVALU INC., Shop 'N Save Warehouse Foods, Inc. and Cub Stores, LLC in favor of Goldman Sachs Bank USA (recorded with the United States Copyright Office at Volume/Document 9962/053) and (iii) Patent Security Agreement, dated as of October 22, 2018, made by SUPERVALU INC. in favor of Goldman Sachs Bank USA (recorded with the United States Patent and Trademark Office at Reel/Frame 047315/0506) (each such agreement, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, collectively, the "IP Security Agreements" and each such grantor thereunder, a "Grantor" and, collectively, the "Grantors");

WHEREAS, pursuant to the IP Security Agreements, as security for the payment or performance, as the case may be, in full of the Obligations, each Grantor granted to the Existing Agent and its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to the Patents set forth in Schedule A hereto, the Trademarks set forth in Schedule B hereto, and the Copyrights set forth in Schedule C hereto (collectively, the "Intellectual Property Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, the parties hereto, intending to be legally bound, hereby agree as follows:

1. The Existing Agent hereby assigns to the Successor Agent each of the Liens and security interests granted to the Existing Agent in its capacity as the Collateral Agent under the IP Security Agreements for its benefit and the benefit of the Secured Parties, together with any claims, awards, and judgments, if any, in favor of the Existing Agent in its capacity as the Collateral Agent under the IP Security Agreements, and the Successor Agent in its capacity as the successor Collateral Agent hereby assumes all such Liens and security interests, for its benefit and for the benefit of the Secured Parties.

2. The parties hereby authorize and request (i) the Commissioner of Patents to record this Assignment in the United States Patent and Trademark Office, (ii) the Commissioner of Trademarks to record this Assignment in the United States Patent and Trademark Office, and (iii) the Register of Copyrights of the United States Copyright Office to record this Assignment in the United States Copyright Office.

3. This Assignment has been entered into pursuant to and in conjunction with the Successor Agent Agreement, which is hereby incorporated by reference herein. The provisions of the Successor Agent Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Successor Agent with respect to the Intellectual Property Collateral are as provided by the Loan Documents (including the IP Security Agreements), and nothing in this Assignment shall be deemed to limit such rights and remedies.

4. THIS ASSIGNMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (INCLUDING NEW YORK GENERAL OBLIGATIONS LAW SECTION 5-1401).

5. The parties hereby agree and acknowledge that, from and after the Effective Date, the Successor Agent shall be, and shall be deemed to be, the Collateral Agent under the IP Security Agreements. In furtherance of the foregoing, as of the Effective Date, unless the context otherwise requires, all recitals, introductory paragraphs, defined terms and other references to "Goldman Sachs Bank USA" as the Collateral Agent in the IP Security Agreements are hereby deemed amended to reference "Credit Suisse AG, Cayman Islands Branch" as the Collateral Agent thereunder.

6. Upon the execution and delivery of this Assignment by the Existing Agent, the Successor Agent, and the Loan Parties, this Assignment shall be deemed to be a Loan Document, and the Credit Agreement and the other Loan Documents shall, where the context requires, be read and construed throughout so as to incorporate this Assignment.


