**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks, (this "Release Agreement"), dated as of February 11, 2021, is made by Tiger Finance, LLC, a Delaware limited liability company, as the administrative agent (hereinafter referred to as the "Administrative Agent"), in favor of FRANCESCA'S COLLECTIONS, INC., a Texas corporation, and FRANCESCA'S SERVICES CORPORATION, a Texas corporation (collectively, the "Grantors").

WHEREAS, Grantors and JPMorgan Chase Bank, N.A. (the "Lender") entered into that certain Trademark Security Agreement, dated as of May 25, 2018, as amended by that certain Amendment and Reaffirmation of Trademark Security Agreement, dated August 13, 2019 (as it may be further amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), whereby Grantors granted to the Lender a security interest in all of the Grantors' right, title and interest in and to certain trademarks, including the United States trademarks listed on Schedule A attached hereto (the "Released Trademarks"); and

WHEREAS, the Trademark Security Agreement was recorded with regards to the Released Trademarks with the United States Patent and Trademark Office (the "USPTO") on February 13, 2019 at Reel 6561, Frame 0831 and on August 16, 2019 at Reel 6722, Frame 0155;

WHEREAS, on December 1, 2020, the Administrative Agent and the Lender entered into that certain Assignment and Assumption, whereby the Lender assigned and transferred to the Administrative Agent all of the Lender's right, title and interest in the Lender's rights and obligations in its capacity as a Lender under that certain Credit Agreement, by and among, the Lender, the Grantors and the other loan parties party thereto (the "Credit Agreement"), and any other documents or instruments delivered pursuant thereto to including the security interest in and to the Released Trademarks, and the Administrative Agent accepted and assumed all of the Lender's right, title and interest to the Lender's rights and obligations in its capacity as a Lender under the Credit Agreement and any other documents or instruments delivered pursuant thereto to including the security interest in and to the Released Trademarks;

WHEREAS, the Assignment of Trademark Security Agreement was filed with the USPTO on February 10, 2021 at Reel and Frame No. 7188/0843;

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied as related to the Released Trademarks; and

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest and all of its right, title and interest in each of the Released Trademarks, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Release and Assignment. The Administrative Agent hereby discharges, terminates and releases its security interest in each of the Released Trademarks (as listed on Schedule A hereto), and the Administrative Agent hereby assigns and transfers to the Grantors, without recourse, all of the Administrative Agent's right, title and interest in and to each of the Released Trademarks and the related trademark registrations and associated goodwill, effective as of the date set forth above. The Administrative Agent authorizes the recording officer in the United States Patent and Trademark Office to cancel these security agreements of record.

2. Further Assurances. The Administrative Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantors' sole cost and expense.


